## TERMS & CONDITIONS

**Enrollment & Deposits:** All customers wishing to participate in this program must enroll in the Metropolitan Preferred Partner Program (PPP), complete this enrollment form and place a non-refundable deposit of CAD 350 per person. This deposit will be applied to your trip account once your trip is completed.

<b>Trip Costs:</b>	Double Occupancy:	34,600 points per couple
	Single occupancy:	23,000 points per person
	Third or fourth person, as adult:	12,400 points per person <i>(13 years and older.)</i>
	Third or fourth person, as child:	9,200 points per person <i>(Under 13 years old)</i>

**Vancouver Pre-trip Extension:**

Double Occupancy:	8,700 points per couple
Single occupancy:	6,600 points per person

**Additional Trips:** There is no limit to the number of trips you may earn.

**Promotional Account:** Trip points *(earned via Product Overbills and Metropolitan Bonus Point Opportunities)* will be deposited into the customer's Preferred Partner Program (PPP) account on a monthly basis. If at any time during the promotional period, the funds in a customer's PPP account fall short of covering their goal in accordance with Metropolitan Progress Schedule, Metropolitan reserves the right to invoice in the amount required to keep the customer "on target" to qualify.

**Entry Requirements:** All citizens of Canada are required to present either:

- One photo identification issued by a Canadian federal, provincial or territorial government with your full name and date of birth or
- Two pieces of identification issued by a Canadian federal, provincial or territorial government. Both must have your name and at least one must have your full name and date of birth.

All government-issued identification documents (Canadian or foreign) must be valid. They cannot be expired.

**Cancellations:** Any customer wishing to drop out of this program may do so. Any cost incurred by Metropolitan Floors as a result of cancellation will be deducted from the customer's Preferred Partner Program (PPP) account or invoiced to you if your account does not cover. **Bonus points contributed by Metropolitan are not refundable and may not be used to cover any cancellation charges.** Remaining points will be held in your Metropolitan PPP account for future trips or refunded on request.
